

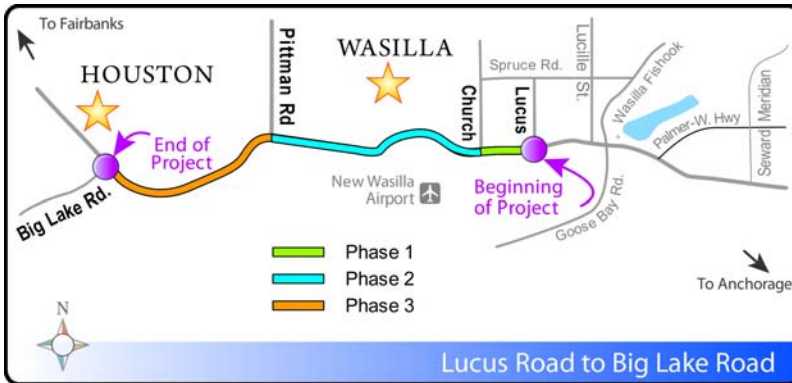

## Project Scope

In September 2010 the State of Alaska Department of Transportation and Public Facilities (DOT&PF) finalized the environmental assessment (EA) for the project, finalized selection of the preferred alternative, and received a Finding of No Significant Impact (FONSI) for the Parks Highway MP 44-52 Lucus Road to Big Lake Road project from the Federal Highway Administration (FHWA). The FONSI cleared the way for the detailed design of the project to begin. Design funding is now in hand for all phases. Phase 1 consists of a 5-lane section from Lucus Road to Church Road; starting at Phase 2, the preferred alternative is a 4-lane section with a depressed median from Church Road to Pittman Road



with limited access and several new frontage roads; and the same 4-lane section continues through Phase 3 from Pittman Road to Big Lake Road. The EA is available on the project Web site (see address below) or you may request a digital copy by calling the public involvement coordinator.

DOT&PF's consultant team led by Hattenburg Dilley & Linnell, LLC is actively working on the design for all three phases. Right of Way acquisition

has begun on Phases 1 and 2. The team is working to fine tune details as issues arise. Keep checking the project web site as the team periodically posts the aerial photos showing the design in progress.
